Facility:	Scott High School , Taylor Mill, KY 5400 Old Taylor Mill Road, Taylor Mill, KY 41015 <u>This meet is NOT held at Silverlake.</u>
Pool:	The facility consists of one 6 -lane course. There is a fully automated touch pad timing system with readout.
Age Groups:	Ages 9 and under.
Type of Meet:	Timed Finals for all age groups. The 9 year old events must be slower than the current National “BB” time standards. A list of Cut Off times is enclosed and will be <u>strictly enforced</u> . This meet is designed to allow the younger swimmer to end the season on a fun and positive note.
Scoring:	This meet will not be scored. This meet highlights the individual swimmer not the team.
Awards:	Participants - All participants in the meet will receive a trophy at the ceremony immediately following the last event. Individual - 1 st through 12 th places Relays -1 st through 6 th places
Rules:	Current USA Swimming rules will govern the conduct of the meet. All swimmers, coaches and officials must be registered USA Swimming members. Coaches and Officials must wear their USA Swimming card while on deck. Age on the first day of the meet will determine age group for the meet.
Entry Fees:	\$4.00 per individual event; \$7.00 per relay. \$2.00 per swimmer Ohio LSC charge Entry Fees must accompany entries or be received within four working days for the electronic (email) entries. Please make checks payable to Northern Kentucky Clippers Swimming, Inc. Entries will not be accepted without payment.
Entry Limits & requirements:	<ul style="list-style-type: none">▪ This meet will be limited to 200 swimmers, including Clippers. No teams will be divided. No deck entries or changes will be accepted.▪ Swimmers MUST be entered in 3 individual events to compete in this meet.

	<ul style="list-style-type: none"> ▪ Swimmers may compete in five individual events, plus one relay. ▪ Clippers do not have to meet the minimum# of swim requirement.
Disability Swimmers	<p>Swimmers with disabilities are welcome to enter Ohio swimming meets. Coaches: 1. Enter the swimmers on Hy-Tel or the paper entry form; 2. Provide advance notice of any necessary accommodations; 3. List in the email with the entries (or on paper) the swimmer's name, entry times, strokes/distance, days/sessions, and how the swimmer prefers to be seeded. Swimmers with disability will be seeded with the same age grouping either the same distance race or a longer distance race (i.e. 500 free during the 100 free). Qualifying time standards at regular season meets are waived for swimmers with disability. For more info go to 'adapted' on the Ohio Swimming website.</p>
Entry Deadline:	<p>Entries must be received by January 20, and not before January 12. Entries can be sent on a disc or via email to clippers.swimming@clipperswim.org A paper copy along with the check and the USA Swimming Registration Form must be sent with the disc. Or if entries sent by email, a copy of entries must be sent at the same time for verification. Files should be loadable into Hytek Meet Manager using Commlink II.</p>

Final Results:	<p>Clippers will publish results on our web page at www.clipperswim.org</p>
Warm-Ups & Starting Times:	<p>Warm ups will be divided up by teams and will be announced on our web site. Start times are on the order of events page.</p>
Warm-up Procedures:	<p>Ohio LSC Swimming Safety Guidelines and warm-up Procedures will be in effect at this meet, depending on number of entries we reserve the right to assign warm up lanes.</p> <p>Each warm-up session will be split into two parts:</p> <p>The first part will consist of two-thirds (2/3) of the warm-up session allotted times and will be general warm-up in all lanes. NO DIVING or RACING STARTS ALLOWED from the blocks or edge of pool. Swimmers must enter the pool feet first in a cautious manner with <u>one hand in contact with pool edge</u>.</p> <p>The second part will consist of the remaining one-third (1/3) of the allotted time, and will be designated for sprint and pace as assigned by the Marshall.</p>
Officials:	<p>Any USA Swimming official who would like to officiate, please contact Clippers via e-mail or send a note along with meet entries. Please note your certification level, if an Ohio LSC official. We will rotate officials through all eligible positions.</p>

Directions	<p>Coming from Ohio through downtown Cincinnati – Take I-75 south to I-275 east and get off at the Taylor Mill Road. Turn right at the end of the exit. At the first stop light, turn right onto Old Taylor Mill Road. Go approx. 2 miles, turn right at the drive way mark for Woodland Middle School. Proceed up the drive and at the stop sign, you will see Scott High School and the entrance to your left.</p> <p>Coming from Ohio – Take to I-275 west and get off at the Taylor Mill Road. Turn left at the end of the exit. At the second stop light, turn right onto Old Taylor Mill Road. Go approx. 2 miles, turn right at the drive way mark for Woodland Middle School. Proceed up the drive and at the stop sign, you will see Scott High School and the entrance to your left.</p> <p>Coming from Northern Kentucky – Take I-75 to I-275 east and get off at the Taylor Mill Road.
